



## **Rules for the Raffle of Hope for Wild Animals 2023**

### **Preamble**

The organizer of the Raffle is the Univet Nature Endowment Fund, whose head office is located at 427 avenue Font-Roubert – 06250 MOUGINS – SIREN 883 663 114. Univet Nature was created in 2018 by veterinarians and ecologists to respond to several reports :

- Animal and plant biodiversity is collapsing all over the planet, this collapse is fastest in the tropics where the stakes are greatest,
- In these regions, the destruction of human origin is accelerated by poverty,
- This destruction in turn creates more poverty there, and increases the risk of pandemics,
- Actions for the conservation of tropical natural environments are effective when they are based on programs to combat poverty and for education,
- There are many associations committed to these programs, supported by very committed people, and who are all limited in their actions by the lack of money.

Univet Nature was therefore created to support nature protection associations selected by the Fund for the relevance of their program, the commitment and integrity of their leaders. At the beginning of 2023, Univet Nature finances the actions carried out by 13 associations under French law working in Madagascar, South-East Asia, Polynesia, the Mediterranean and Provence.

### **Article 1 – Organization**

The Univet Nature Endowment Fund is organizing from March 10, 2023 (0:00 a.m., time of participant's place of residence) to November 15, 2023 (midnight, time of participant's place of residence) a Raffle whose profits will be donated to programs for protection of nature.

These programs are part of the projects carried out by the 13 partner associations of Univet Nature, or by other associative actors if the Board of Univet Nature so decides.

## **Article 2 – Participants and conditions of participation**

- The Raffle is open to any adult person of any nationality. The Raffle is also open to any minor of French nationality with the authorization of the legal guardian.
- To participate in the Raffle, it is necessary to fill in the information allowing the identification of the participant (surname, first name, email, postal address, date of birth).
- There are 3 ways to participate:
  - 1/ Buy one or more tickets, these tickets can be drawn at the time of the allocation of the 100 Prizes (Articles 4-5-6).
  - 2/ Register for the Challenge, the 50 best challengers will receive a Reward (Articles 7-8-9).
  - 3/ Buy tickets AND register for the Challenge.
- Anyone who has purchased a Raffle ticket on <https://univetnature.org/tombola2023> or on <https://univetnature.org/en/raffle2023>, or who has got a Challenger number from the Contacts Alain Moussu ou Marie Jacquier (Article 7) can participate in the Raffle. There is no other way to enter the Raffle.
- Any inaccurate or misleading statement, any fraud that could harm the smooth running of the Raffle or the Challenge, any non-compliance with these rules, may result in the immediate cancellation of the participant concerned without notice.
- The purchase of tickets will not allow participants to benefit from a tax deduction.
- The purchase of tickets is only possible if you have a means of payment compatible with those offered on <https://univetnature.org/tombola2023> or <https://univetnature.org/en/raffle2023>
- The organizers of the Raffle of Hope for Wild Animals 2023 cannot participate in this Raffle. However, these people can participate in the Challenge.

## **Article 3 – Methods of payment**

60,000 tickets will be on sale at a price of €5 each on the page <https://univetnature.org/tombola2023> and on <https://univetnature.org/en/raffle2023>, exclusively by credit card.

To be able to finalize the payment, it is necessary to have a bank card (CB, MAESTRO, MASTERCARD, VISA or VISA ELECTRON) and to benefit from a 3D Secure verification system.

Payment is free of bank charges from any country in the euro zone. Outside the euro zone, the bank may charge a conversion fee to the participant.

Participation is not limited in terms of quantity of tickets purchased per person.

#### **Article 4 – Endowment**

The Lots are gift vouchers that promote the discovery of nature, usable with Escursia, specialist in naturalistic travel ( <https://www.escursia.fr/> ) and the Shop of the League for the Protection of Birds ( <https://boutique.lpo.fr/> ).

The Raffle has 100 Prizes, a total value of € 31,025.

1st Prize : an Escursia gift voucher for €10,000

2nd Prize : an Escursia gift voucher for €5,000

From the 3rd to the 5th Prize : 3 Escursia gift vouchers €1,000 each

From the 6th to the 27th Prize : 22 LPO gift vouchers €400 each

From the 28th to the 59th Prize : 32 LPO gift vouchers €100 each

From the 60th to the 100th Prize : 41 LPO gift vouchers €25 each

If the circumstances so require, Univet Nature keeps the right to substitute, at any time, for the proposed endowment, an endowment of equivalent value or similar characteristics, without this giving rise to any compensation or indemnity of any kind.

#### **Article 5 – Draw**

The draw will take place on November 16, 2023 at 2 p.m. in Mougins in the presence of Christophe Navarro, president of Univet Nature, or Alain Moussu, director of Univet Nature, and Maître Marjorie Hernandez, bailiff at 799 avenue Tournamy 06250 Mougins. The Mayor of Mougins and the municipal legal department will be invited.

Only one prize will be awarded per winner.

The draw will be based on dedicated software such as <http://my2lbox.com/fr/tirage-au-sort-liste>. The choice of this software and the terms of its use will be validated by Maître Marjorie Hernandez.

The participant wins when the number of the ticket he has purchased is drawn.

The immediate elimination of the participant in the Raffle can be carried out without delay or notice, if it turns out that there has been cheating.

## **Article 6 – Withdrawal of Lots**

The 100 winners will receive their Lot (dematerialized gift voucher) by email, no later than November 30, 2023.

The Lot will be definitively lost in the event that Univet Nature fails to contact the winner after the draw (invalid email address and postal address), or if the winner declares that he refuses the Lot. The Lot will then be put back into play during future operations.

## **Article 7 – Presentation of the Challenge**

- The Univet Nature Endowment Fund will reward the 50 most committed people in the sale of Raffle tickets, but only if they are registered for the Challenge. For that, the future Challenger must get a Challenge number from the Contacts Alain Moussu ([alain.moussu@univetnature.org](mailto:alain.moussu@univetnature.org) / tel : +33 6 23 75 70 94) or Marie Jacquier ([marie.jacquier@univetnature.org](mailto:marie.jacquier@univetnature.org) / tel : +33 7 70 24 84 51).
- Everyone can however participate in the Raffle, i.e. buy tickets, without participating in the Challenge. You can also participate in the Challenge without buying tickets yourself.
- The Raffle ticket purchase form will include an optional question : *If you participate in a Challenge or if you support a Challenge, enter its number here.*
- The Challenge numbers will be ranked by decreasing number of occurrences among the purchased Raffle tickets. The 50 most frequently assigned numbers on a ticket will entitle the holder to a Reward.
- To be qualified as the winner of the Challenge in one of the first 3 categories described in Article 8, it is also necessary to reach a minimum threshold of occurrences. The number of Rewards distributed can therefore be less than 50 : it will be between 43 and 50.
- The list of Challenge winners and the Rewards awarded to each will be validated in the presence of the same people as for the draw on November 16, 2023.

## **Article 8 – Challenge Rewards**

The Rewards are gift vouchers that promote the discovery of nature, usable with Escursia, specialist in naturalist travel ( <https://www.escursia.fr/> ) and the Shop of the League for the Protection of Birds ( <https://boutique.lpo.fr/> ).

The Challenge has 50 Rewards, with a total value of € 7,825.

1st Reward : an Escursia gift voucher for €3,000 provided it exceeds 200 occurrences.

2nd Reward : an Escursia gift voucher for €1,000 provided it exceeds 100 occurrences.

From the 3rd to the 7th Reward : 5 LPO gift vouchers €400 each provided it exceeds 50 occurrences.

From the 8th to the 17th Reward : 10 LPO gift vouchers €100 each.

From the 18th to the 50th Reward : 33 LPO gift vouchers €25 each.

If the circumstances so require, Univet Nature keeps the right to substitute, at any time, for the proposed endowment, an endowment of equivalent value or similar characteristics, without this giving rise to any compensation or indemnity of any kind.

### **Article 9 – Withdrawal of Rewards**

The winners will receive their Reward (dematerialized gift certificate) by email, no later than November 30, 2023.

The Reward will be definitively lost in the event that Univet Nature fails to contact the winner (invalid email address and postal address), or if the winner declares that he refuses the Reward. The Reward will then be put back into play during future operations.

### **Article 10 – Limitation of liability**

The Univet Nature Endowment Fund reserves the right to modify or cancel the operation, due to any event, without being held liable. In this case, participants will be reimbursed the price of the participation voucher.

### **Article 11 – Dispute and litigation**

These rules are subject exclusively to French law.

Participation in this operation implies the participant's full acceptance of these rules.

Any dispute related to this operation must be made in writing, within 7 days of the declaration of the winners to Univet Nature – 427 avenue Font-Roubert – 06250 Mougins - France.

The Prizes and Rewards cannot give rise to any dispute whatsoever on the part of the participants. The winner may not under any circumstances claim the replacement of the prize by another, or demand reimbursement of the latter.

### **Article 12 – Submission and consultation of the rules**

These regulations are filed with the Bailiff's Office of Marjorie Hernandez, 799 avenue Tournamy 06250 Mougins.

### **Article 13 – Personal information**

The personal information collected in the context of this Raffle is processed in accordance with the general data protection regulation (GDPR), which came into force on May 25, 2018.

The GDPR is a continuation of the French Data Protection Act of 1978 establishing rules on the collection and use of data on French territory.

It will not consist of files of people who have participated in the Raffle or the Challenge. Participants may however authorize Univet Nature to send them information on its news and on its next calls for donations. To do this, participants must tick a dedicated box on the page <https://univetnature.org/tombola2023> or on <https://univetnature.org/en/raffle2023>.

Participants are informed that the personal data concerning them, recorded as part of this Raffle, are necessary for their participation to be taken into account. The participants benefit from the organiser, the sole recipient of this information, a right of access, rectification and cancellation of the information collected concerning them. They will appear on the list of participants as anonymous, and will receive a confirmation of participation by email, with their assigned ticket number.
